Public comment for agenda items is limited to 1 minute, with a cumulative total of 3 minutes for multiple agenda items. General public comment shall be limited to a cumulative total of 2 minutes, unless adjusted by the presiding officer of the Board.

If you believe the council is not following the law or its own rules you may file a grievance in writing with copies to both the Chair and the Secretary.
